## MISCELLANEOUS FEES

- Annual Registration/Curriculum Fee: \$100 per child. Max fee of \$200 per family. Charged annually in September. Initial fees paid May 1-August 31 applied to the upcoming school year. Non-refundable.
- Late Pick-up Fee (per child): \$15 for first 10 minutes past 5:00 pm. Additional \$1 for every minute after 5:10 pm. Upon third late pick-up, fee increased to \$25 for first 10 minutes past 5:00 pm. Additional \$1 for every minute after 5:10 pm.
- Failed Payment Fee: \$50 per failed payment. Keep Brightwheel payment method current & with sufficient funds/credit.
- Finance Fee: \$30/week late fee for delinquent accounts. Outstanding balances risk disenrollment.
- Summer Supply/Curriculum Fee: \$35 per child. Due in spring for current KPS families to secure child's spot in the summer preschool program.
